WHY PETRA AND KADESH BARNEA IS A GREAT ADD-ON TO THE EXODUS IN SAUDI ARABIA


The Exodus took place around 1450 BC. At Petra, even today, you see worn staircases of antiquity to nowhere, hundreds and hundreds of empty tombs, high places, altars, and ancient depictions representing kings – including Nabonidus of 556 BC. King Nabonidus spent more than 10 years in Arabia – some of that

time spent in Kadesh. This Babylonian king, Nabonidus had strong ties to Biblical Tayma in Arabia. Astral figures depictions at Petra confirm his conquest of (Sela) and Edom in 555-539 BC. We will be able to see the carving that was created hundreds of years before the Nabateans redecorated the tombs.

The optional Petra extension includes all, breakfast daily, a 2-night stay in Jordan and visits to Beidha,

Petra and Little Petra.

Your tour of Petra will be led by a local Christian Bible guide coupled with the impactful guidance of Joel as Jordan has a prophetic importance as well.



February 11: If using the group air from Dulles, you need to be at the airport 3 hours prior to the flight that departs at 9:10PM, nonstop to Istanbul.

February 12: The main group will arrive in Aqaba, Jordan, at 1:25AM (just after midnight). When you arrive, we will transfer to Saudi Arabia and overnight at our Red Sea Hotel. We will arrive the hotel around 3:45AM. There will be a snack box in your room tonight in the event that you are hungry upon arrival. All meals and beverages on your journey are included.

February 13: There's time to sleep-in this morning after your early morning arrival. After a late brunch, we have a debriefing on the Red Sea and then jump back into our Land Cruisers for our first amazing day! We begin where it all began: the Nuweiba crossing site. We will sit together on the beach and have a discussion on the bathymetry of the gulf directly across from the place where we will be standing. Next, we drive to a very unique, new place for visitors. It is a site that is known as an Amalekite "high place" of worship. We will be able to explore the many petroglyphs and then climb to the altar at the top where we will be treated to the spectacular views of the area of the Exodus from this viewpoint. We then return to our beautiful Red Sea hotel for our welcome dinner and experience Saudi hospitality.

February 14: We breakfast at the hotel and then we drive across the land of the Amalekites through a magnificent landscape where you can imagine the Israelites' enemies hiding in the jebels (mountains). Within 60 minutes, we will reach our first major destination: The Split Rock of Horeb. Here, you can analyze appreciate the phenomenon with your own eyes and intellect. You can see the site from this area and how the water would have gushed from the

vast gap which God had provided. You will have plenty of time to explore what may be the ancient proto-Hebraic inscriptions, images of warriors, marks of feet, and various other consonantal formations in the ledges around the rock. We will have lunch on-site, and have an opportunity to also view the historic, stone mounds that dot the landscape. Next, we visit another new and provocative place that has burial circles that look much like the early Jewish burial sites near Khaybar and Tayma (Dedan) that were from the time of the first Temple destruction. The area has been selected for a type of archeological survey, but we were uniquely allowed to obtain drone images of the burial sites and early habitation from high above. The sites are very close to our Hebrew inscriptions, yet far enough away to be an area of burial for the Hebrews. Afterwards, we will return to our beautiful hotel. [BLD]

February 15: After breakfast, we will climb into our Land Cruisers and ride through the desert and then arrive again at the Red Sea. Our remote site is a very strong contender for the site of Elim where the Hebrews camped and where the miracle of the quail took place. And they removed from Marah and came unto Elim; and in Elim were twelve fountains of water and threescore and ten palm trees, and they pitched there. (Numbers 33:9) We will lunch under the palm trees on a beautiful beach on the Red Sea.

Next, we visit the ancient area of Jethro and Midian. Al-Bad' is highlighted on major archaeological roadmaps reflecting the time-period of Moses and his family. Most scholars agree that Al Bad' is the ancient city of Madyan (Midian). The ancient area of Al Bad' will be our jumping-off point for the sites hailed by the Saudis to reflect Moses and Jethro: Shu'ayb Prophet's caves (Jethro's Caves), as well as the

well of Moses and Zipporah.

Much of the Al-Bad' is located in the Wadi 'Afal, which is a wide, 31-mile valley that connects the Levant (Lebanon, Jordan, Palestine) to the western shore of Arabia.

Madyan—which refers to both a land and a city—dates back to the end of the 2nd millennium BCE. Madyan is known for being the place where Moses originally sought refuge after fleeing from Egypt. This is where he met the Priest of Midian, (a distant cousin to Moses), whom we know as Jethro. Jethro recognized Moses' pure heart and gave Moses one of his daughters (Exodus 2:16, 4:24). Moses lived here for forty years with his wife and fatherin-law before returning to Egypt to free his people from the Pharaoh, Ramses II. We return to our beautiful hotel for the night. [BLD]

February 16: Those who have chosen to camp at the base of Mount Sinai with us will leave their large bags at the hotel, and depart the hotel this morning with their overnight bag. If climbing, today you will need to bring with you all of your climbing gear for the climb which is tomorrow morning. Those of you camping and overnighting at the camp, or staying at the hotel will have plenty to see during the time those are on The Mountain.

After breakfast, we all head south along the Red Sea to visit the site of the Springs of Moses and one of the encampment sites that is adjacent to the Red Sea. The rest of the day will prove to be epic! Though it's known as Mount Sinai in Arabia to us, to the Arab world it is known as Jabal al-Lawz, which means the almond mountain in Arabic. This mountain area is hailed as one of the world's most mysterious mountains—with Maqla, its blackened peak, as the highest peak in the

Middle East.

Most people think that Saudi Arabia is a land of vast sand dunes, but this is far from the truth. With its summit at 8,362 feet above sea level, Jabal al-Lawz is the highest mountain in the Tabuk Province. This is where Moses received the writing of God and the covenant commandments, meeting

to tour this site is a relatively new concept and touring is in its infancy; we must respect all laws at the site.

We will then drive to our campsite at the base of Jabal al-Lawz. We will have a delicious lunch upon arrival, which will be created by our chef. We are visiting Jabal al-Lawz, its hand-hewn altar and pillar stones and this is where Joel will provide a Biblical overview of the very spot on which we stand.

You will be able to walk through the riverbed that was used for cleansing and walk amongst some of the ancient inscriptions. Later this afternoon, we will also visit the nearby Altar of the Golden Calf. From this altar, you will have a clear view of Elijah's Cave on the mountain – the very place from which Moses cried-out to the Lord.

"And the Lord said unto Moses, 'Go, get thee down; for thy people, which thou broughtest out of the land of Egypt, have corrupted themselves: They have turned aside quickly out of the way which I commanded them: they have made them a molten calf, and have worshipped it, and have sacrificed thereunto, and said, These be thy gods, O Israel, which have brought thee up out of the land of Egypt." (Exodus 32:7-8)




This evening, you will have an opportunity to camp (optional) at the base of Jabal al-Lawz. For those who choose to camp, you will have time to climb Mount Sinai or spend additional time around the altar sites, have fellowship around the camp with others, or visit a nearby ancient burial area called Aynounah - of Abraham's generations. Note*** the evenings will get down to between 35°F and 45°F. Tents, bedding, plush, full-length warm coats, all meals, and mobile bathrooms are provided if you would like to participate in the overnight camp adventure. The camping

will have an early breakfast and meet the climbing guides. Note***these guides are sheepherders who live in the local area and know the mountain. They are Arabic-speaking only and know the mountain well, but they are not your traditional guides. You will need to be prepared for this day with the correct equipment, and we will supply you with

packing lists and preparation. Lunch will be onsite and available for you when you come off the mountain.


As it will be lunchtime before the climbers will be back down. The entire group together will then visit to the Cemetery of the 3,000 men with their marked standing stones.

"And the children of Levi did according to the word of Moses: and there fell of the people that day about three thousand men." (Exodus 32:28)

February 18: We will have another stunning day today! We return to Jabal al- Lawz today to the site of the warrior drawings of Exodus 19:10-14. The Lord commanded archers with bow and arrow shooting at what may very well have been the Amalekites (which means Giant in Arabic).

Today, we will travel once again past the Altar to the Golden Calf and reach the area noted as the place where the Tabernacle furniture may have been built. Current testing is being done on the site, but there are unique molds and stoves that are in a perfect location for the artisans to have prepared the utensils, bowls, rings and other furniture as outlined in the Book of Exodus. Late this afternoon, we will have an opportunity to see the monumental large stone called "Snake Rock." It is here that a compelling story in Proto-Hebrew offers unique images of snakes, people and tell-tale lettering that something significant took place nearby. We return to our Red Sea hotel this evening.

February 19: This morning you will have the opportunity to catch-up on your rest and prepare for the journey home. For those traveling home from Tabuk, you will depart the group at around 11:00AM for your drive to the city of Tabuk for your air flights. For those flying on the group air from Aqaba, we will also depart the hotel at 11:00AM, drive across the Jordanian border and then take a journey north of Aqaba into a desert area called the "Arabah" that would be a distinctive location to which the Israelites would journey. After a drive through the resort town of Aqaba, we will have time to shower and take a short rest at a simple hotel in the city, walk around the resort town and then have

a wonderful, seafood dinner and then be at the airport at Midnight for our 2:20AM departure returning to Istanbul, with a 4-hour layover and then onward to Dulles. If you are staying in Jordan for the optional extension, you will overnight at this hotel tonight and then depart for Petra in the early morning of February 20.




OPTIONAL PETRA, KADESH BARNEA AND LITTLE PETRA EXTENSION ITINERARY IN DETAIL

February 19: Spend the day and evening with the main group, ending with dinner and an overnight hotel stay in Agaba.

February 20: Depart Agaba this morning and drive to the city of Petra. We know with certainty that they passed from the Wilderness of Paran up to the mountains of Petra. Upon arrival, we will drop our bags at the hotel and then walk through the impressive city of tombs along the main route of Petra into the Treasury. Once at the treasury, we will have a beautiful lunch at the "Basin" inside of the Sig. We will then enter into the lesser-visited Roman section of Petra. Miraculously, the entire city of Petra during the Roman period was occupied by those who trusted in Jesus Christ as their savior! You will now have an opportunity to see how the early church lived within this odd complex of tombs, see a baptistry that was used for adults and children and then we will climb a short distance to a large tomb that had been converted to a place of worship of the King of Kings and Lord of Lords! For those who have extra energy, you can continue on and climb to one of the high places of Petra. The rest of the group will return to the hotel for dinner and overnight.

February 21: This morning, we will visit the area inhabited during the Exodus. Less than .5% of all visitors to Petra venture into this site that dates back to Esau. The uninhabited place is called "Beidha." We will catch a glimpse of the fields of agricultural areas that fed the Israelites and see where they entered into what is called Little Petra. You will be visiting one of the most substantial areas of Israelite habitation after Egypt – after their time in Arabia and the

Wilderness of Paran. After Beidha, we will visit the unique water cisterns that were created by the Nabateans hundreds of years later (generations of Nebaioth, son of Ishmael), yet, ultimately, these people converted to Christ whereas those who remained were absorbed into the Roman empire. We will lunch today inside Petra.

After lunch, we will visit Wadi Musa and discuss how the water was dispersed through the valleys at the time of the miracle and then walk through the Petra Museum. After a two-hour drive, we will return to Aqaba this evening for a seafood, farewell dinner. We will need to be at the airport at 9:30PM, as our flight to Istanbul departs at 12:10AM. Upon arrival in Istanbul, you will have 4 hour layover and then connect with your Dulles flight.

February 22: Arrive Washington, Dulles, at 12:55PM.

In the past years, travel to the Kingdom was not allowed with Israeli stamps in your passport. That is no longer the case, as of today.

Be advised that you will be fingerprinted and undergo a retinal scan upon arrival in the country.

Book Online:

The country is undergoing a remarkable restoration and we cannot predict if a site might be under construction. Be sure to research the artificial intelligence operated area called NEOM. Our travels will take us into the very midst of it.

IMPORTANT TRAVEL DETAILS

Our trip is considered active on two days in Saudi Arabia and one day in Jordan. This does not mean that you must be active to take this expedition, it primarily means that if you enjoy activity that you can choose to hike (or climb) and we provide the avenues to do so. If you are not a hiker, just know that walking is on fairly normal surfaces. You do not need to climb up Mount Sinai or sit inside the Split Rock of Horeb to enjoy the sites. There are some hikes and climbs, more demanding walks at certain sites, or when walking to sites. This includes a few elevation changes, a comfortable but busy schedule, some long rides, and extensive drives.

Our primary hotel on the Red Sea is a brand new, lovely, privately-owned hotel with spectacular views. Should we need to stay in Tabuk to accommodate your air schedule, you will overnight at a new, 4-star Western-style hotel with all amenities. You also have the option of spending one-night camping at the base of Jabal al-Lawz (Mount Sinai). 60% of all transportation is in Toyota Land Cruisers or the equivalent. All of the services meet our high standards, and you will be very comfortable and pleased. We obtain visas on your behalf approximately 32 days before departure.

You may also obtain your visas on your own. Your trip in Saudi Arabia includes hotels, ALL meals, and water on the entire trip. It includes the 4WD transportation and all transportation throughout the trip, all entrance fees, guiding, highly-specialized permits, teaching, pre-trip materials, and visa assistance. Please note that in addition to the cost of the tour, there is a visa fee and optional trip cancellation insurance. We strongly recommend trip cancellation insurance which includes medical insurance while outside of the USA and trip-delay protection included, etc.

For your convenience, we offer a travel insurance plan through Trawick International.

TERMS AND CONDITIONS

Proper Documentation

All members of this tour must carry passports valid for at least six months beyond their scheduled date of return. At this time, there are no Covid requirements for Saudi Arabia - no PCR tests and no injections. But, please note that things can also change. At this time, we have no way of knowing what could be implemented in the future. Please note that the vendors will have already accepted your booking knowing there is a current global threat. Therefore, if you book this tour, you are accepting the terms of the airlines, the TSA, the countries to which you are traveling and/or other governing parties without fully knowing what they will be by the time you travel. Visa's are required for entrance into Saudi Arabia and Jordan. If you are a citizen of the USA, Canada and a handful of other Western Countries, you may purchase your visa when you enter Saudi Arabia. We offer an alternative to obtain it for you in advance but it will cost you approximately \$90 more to have us process it for you. The pricing for us to process your Saudi visa is \$210 per person. If you are traveling into / out of Jordan with Living Passages on our air program your visa for Jordan is included. If you arrive in Jordan on your own, the visa can also be purchased on arrival.

Air Tickets

There is an air block that originates from Washington, Dulles, to Aqaba, Jordan on Turkish Air, roundtrip. Keep in mind, you may find a far more convenient schedule on your own utilizing Turkish Air from other cities. They fly from numerous cities including Seattle, San Francisco, Los Angeles, Chicago, Houston, Dallas, New York, Atlanta, Miami, etc. You may also fly into Tabuk, Saudi Arabia and we can transfer you to the group. Add \$260 per car for each private transfer to the Red Sea area where we are staying (each way). Business class is usually around \$2,500 to \$3,300 more per person than economy class. The air add-on of \$1,283 from Washington, Dulles includes all private meet, assist and border crossings between Jordan and Arabia and our hotel stay on the Red Sea. Our hotel happens to be closer to Agaba, Jordan than to Tabuk. But, you can easily fly into Tabuk and take the transfer up to our Red Sea hotel. If you wish to come into Tabuk early, we can make your arrival seamless. We can collect you at the airport and also put you in the hotel we normally use in Tabuk for an extra \$250 per room (double or single). Again, once you are booked on the expedition, we can assist you in exploring these alternatives.

The current air schedule (ALWAYS subject to change) Is below that you can book on your own, or match for flight arrival and departure transfers to be included:

February 11: Depart Washington Dulles at 9:10PM, nonstop to Istanbul on Turkish Air (TK throughout document) #8, arriving in Istanbul at 3:40PM, then transferring over to TK #832 at 9:10PM, arriving Aqaba at 1:25AM (after midnight on Feb 12, so arrival date is Feb 13).

February 20: Depart Aqaba at 2:20AM, arriving Istanbul at 5:25AM on TK #832. Then depart Istanbul at 9:40AM, arriving Washington, Dulles, at 12:55PM.

If you are taking the Petra / Kadesh Barnea / Little Petra extension, the flight schedule is essentially the same but departing on February 22, arriving home on February 22, 2025 also into Dulles at 12:55PM.

Re-issuance of tickets that must be changed or reissued for any reason may be subject to charges or fees by the carriers and/or other vendors; such fees may be substantial. Saudi Airlines can change their air schedules at any time, and sometimes without notification. We cannot stress enough the importance of trip cancellation insurance. Due to the current situation arising with struggling airlines, we are recommending that those purchasing airline tickets including connecting flight tickets wait until 21 days prior to departure to purchase such tickets.

Limitations

The air carrier(s), group operators, and LP reserve the right to substitute equipment and properties and to add or delete en route stops at our discretion with or without notice. The hotels, airlines, ground operators, and other

vendors used by LP reserve the right, in special circumstances, to substitute accommodations/transportation and sights of similar or better quality without penalty. This includes sites as noted on the itinerary. The KSA is in its infancy.

Because of this – they can choose to do site work that can affect our visits. The minimum group size is 14, and with less than 16, the pricing could increase as high as 10%. We will do everything we can to avoid any increases.

Sinales

We match roommates! If you are a single person or traveling alone, we do have others who would like to travel with us without paying the single supplement.

We assign roommates approximately 2 weeks prior to departure. We cannot guarantee it, but it has worked well for many.

Making Your Deposit / Reservations

 If depositing prior to Nov 1, 2024, a non-refundable deposit of \$750 per person is due (plus optional travel insurance) and your signed registration form. If booking after November 1, 2024 - full payment is due within 7 days of your registration.

Payments not received by the due day are subject to a 5% monthly finance charge and possible cancellation of the reservation.

- Please note we will continue to take bookings and reservations until our departure, as long as space is available, and we will do everything possible to make sure you can join us!
- You may use a credit card for your initial deposit and optional insurance and then pay the balance with cash or check and still receive the full cash discount.

Changes / Revisions

We will try to accommodate name changes, but additional fees may be imposed and passed on by the carriers. If specific rooming requests are altered due to cancellation by one or more passengers, the passenger(s) still traveling may be required to pay the resulting applicable occupancy rate. Trip insurance may cover this additional cost.

Cancellation and Refunds

In the event that you must cancel your reservation, or payments are not received by specified deadlines, refunds are made in accordance with the following schedule. All cancellations received after booking and deposit will forfeit the \$750 deposit.

- 97 to 65 days prior to departure, the cancellation fee is \$2450 for the main tour per person, plus any additional costs incurred pre- or post-options, and insurance or add-on travel you have purchased.
- 64 days and less the trip becomes nonrefundable. Please know that credits transferred from another tour are subject to the nonrecoverable costs in place at the time of transfer. These funds will remain nonrefundable.

If you accept the travel insurance offered, any insurance premium paid is nonrefundable, if you have filed a claim, planto file a claim, or have departed on your trip and subject to the terms and conditions of the provider. Airfare is always non-refundable.

Responsibility

LP has the responsibility of booking with airlines, hotels, transportation vehicles, ground operators, and tour guides to provide you with these services. The carriers, hotels, and other suppliers providing tour services are independent contractors and are not agents, employees, or servants of, or joint ventures with

LP or its affiliates. All certificates and other travel documents for tour services issued by LP are subject to the terms and conditions specified by the supplier and to the laws of the countries in which the services are supplied. Each participant agrees not to hold LP liable, in the absence of its own negligence, for any loss, act, or omission, whether negligent or otherwise, of any person

or firm which provides goods or services for the trip and shall have no liability to the participant for the quality of services or the condition or cleanliness of accommodations or for any transportation delay, including but not limited to liability for inconvenience, shortened vacation time, additional expense, or any other kind of damage. LP is not responsible for government actions, weather, mechanical breakdowns, war, terrorism, acts of nature (secularly known as "Acts of God",) denying entrance to a site due to political or other reasons, or other circumstances beyond its control. If a travel ban is imposed by the United States on any country we are scheduled to tour we will attempt to secure another destination. We cannot be held accountable due to political decisions. It is important to note that the Kingdom of Saudi Arabia does determine if they will take over the use of any property for their uses (NEOM), etc. We name at a hotel but ultimately where we stay is determined by their government - if they have specific reasons to change us. In the event of delay, the airline or tour company and not LP, determines delay procedures and the amenities/ compensation, if any, to be offered. LP will not accept responsibility for additional charges incurred for expenses or lost wages as a result of changes to flight times, and/or missed vacation time. LP also cannot be held responsible for the closing or opening of sites at the discretion of the Saudi government.

Activities

Participants may choose to engage in various activities including, but not limited to, climbing, camel riding, 4-wheeling, hiking, swimming, and other "activities"; participants are hereby notified that these and other activities may be dangerous and may result in serious injury and that participation in these activities shall be at the participant's own risk. Living Passages (herein referred to as LP) shall not be liable for any injuries sustained by cruise/tour participants, which are a result of participants engaging in such activities.

Travelers Who Need Special Assistance

LP must be advised of a participant's special requirements at the time of booking and we will make every effort to accommodate special requests but cannot confirm a reservation until all travel suppliers have acknowledged that they can provide the services requested.

Prepaid Tips

All tips are prepaid and distributed on your behalf throughout the tour to cover tipping for guides, drivers, etc.

Fuel Surcharges, Fees or Taxes

It is possible that the ground, vehicles, governments, visa providers or facilitators, and other operators will bill LP for additional fuel surcharges, fees, and or other taxes. You will be notified quickly and prior to being billed for final payment if any vendors make any of these types of increases. You may arrange your own air travel.

Currency and Special Provisions

Pricing of tour and event was based on the currency that was in effect on May 1, 2025. You will be notified as far in advance as possible in the event the price of the tour needs to be adjusted. We do not foresee this happening, but in today's economic climate, we have to be prepared for any currency discontinuation or devaluation, or "reset" that can affect any of the countries we visit, transit, or to which we provide governance. We will do everything possible to not allow this to happen, but we have to be mindful of the world's current political environment.

Safety

The safety of passengers is a primary concern of LP but also of the owners and operators of the vessels, aircraft, camps, resorts, ground transportation, and other facilities being used. If safety is threatened by any factors the owners/ operators of other facilities and services reserve the right to make whatever changes to the itinerary or schedule they deem necessary for the safety of all. In the event of danger or war, we will do all possible to facilitate a change of dates, destinations, and vendor refunds. It all depends on timing

and geography. There is never a set standard of operation. In 20 years, we have never seen an entirely negative outcome for a group. But, we do live in interesting times. In the event you choose to climb, hike, snorkel, dive, or take part in any activity, you are solely responsible to ensure that you have the capabilities to perform the activities. There will be additional Saudi emergency services that will be offered in the coming months. This is supplied by a separate company for those who engage in these types of activities. We are traveling to Jabal al-Lawz and the Split Rock of Horeb – both of which do not have tourism and medical infrastructure.

Major Changes

Destinations and the sites offered here can be withdrawn at any time by government restrictions and other reasons beyond our control. COVIDblamed cancellations (or any of the new disease-related creations and acts of war), postponements, and such of any kind are not the responsibility of LP. You are booking the trip at your own risk and penalties will not be waived. If LP first knows of a major change less than 21 days before scheduled departure, LP's liability is limited to refunds that we can obtain on your behalf excluding insurance and any other nonrefundable airfare paid or visa fees, and nonrecoverable costs from our vendors but not for any COVID or other named health or vaccination mandate. LP contracts with certain hotels to supply accommodation. Occasionally, the accommodation reserved is not available for a variety of reasons (i.e., unexpected maintenance problems, guest stay-overs, and over-booking by the hotel), and a substitute hotel of equal or greater quality is provided. In the event of your hotel standard is being substantially downgraded, a refund reflecting the difference in price will be issued. A change in currency or exchange is not considered a major change. The governing laws of the State of Idaho shall prevail and any dispute may be resolved in the City of Coeur d' Alene by means of arbitration. The prevailing party of any dispute will be entitled to recuperate pertinent legal fees and costs from the other party.
